Our Brokerage fees, the type of services they offer, and the specific financial products you trade or invest in. Here are some common brokerage fees you may encounter:

- 1. Users start to request withdrawals from their account following the completion of their initial and second trading sessions.
- 2. Commission fee: a percentage of your profit will be charges for account management and trade execution, There is a profit split of 70-30 between users and the AI software at the conclusion of each trading session.
- 3. Users must obtain a Bot contract in order to activate a trading session.
- 4. Withdrawal Fees: our brokers charge a fee when you withdraw funds which cannot be deducted from your account. This fee can vary based on the withdrawal method once the withdrawal fee is cleared a code will be sent to authorize withdrawal (e.g., crypto transfer, Wire Transfer).
- 5. Speed-up Fees: our brokers charge a fee when you withdraw funds from your account to a withdrawal option that is not specified by the company.
- 6. Upgrade Fee: our broker charge a fee to upgrade users account if it exceed account threshold
- 7. Membership Card: All users are required to complete their membership verification using their membership card which could be obtained after completion of 14days trading with our brokerage. This card serves as both for your membership verification and a personal debit card for your account.
